Pendleton reports that one of the highlights of the trip was being able to ride in Sensei Stefanacci's car





### USANKF Nationals, Olympic Training Camp and tournament news

The 2017 USA Karate National Championship and Team Trials were held in Greenville, South Carolina at the Bon Secours Wellness Arena July 19-23. Competition began on Thursday and concluded with the finals on Sunday evening.

Regan McNamara participated in the Senior Kumite -68k division. After 4 matches Regan seeded fifth. As it was her final junior (under 21-years-old) competition, she decided to take a break from karate after Nationals. From Nationals, the top six competitors earned way to the USA National Karate Team Training and Champion-Camp ships in Colorado Springs, Colo. in January 2018. Regan was notified late in

### Human Trafficking program presented by Shihan Ellis

Shihan Jeff Ellis created and organized an initiative along with community leaders from the police and fire departments, Ohio State Highway Patrol, city schools, and Southwest General Hospital to make a positive difference in Strongsville and surrounding communities with human trafficking. Together in partnership with the Collaborative To End Human Trafficking, a community awareness program, was held in November at Strongsville Middle School.

Karen Walsh, the collaborative's CEO, gave an overview of what Human Trafficking looks like. One of three speakers was survivor and author Theresa Flores who was trafficked for two years. Det. John Morgan from Cuyahoga County Sheriffs Dept. told of

some of the cases he has worked on in the past relayed how frequently this is happening in every neighborhood. Teresa Stafford from the Cleveland Rape Crisis Center provided more details about the victims and survivors they see, and provide services for, regarding this topic. Fourteen community service providers were on hand offering more information. A panel including Judge Rini from the Cuyahoga County Court, who is also a Sexual Assault Nurse Examiner (SANE nurse) from Rainbow's Babies & Children's Hospital, answered questions from the nearly 200 in attendance for almost an hour.

### USA dominated WCJJO World Championships in Australia

The USA Sports Jujitsu Alliance® Team dominated the 2017 World Council of Jujitsu Organizations (WCJJO) World Championships held on October 27-29, 2017, on the Gold Coast in Australia. USA dominated by taking 32 of the 44 available gold medals winning the majority of the divisions in Brazilian Jujitsu grappling (BJJ), individual sports jujitsu fighting competition including both adult and senior divisions and by taking the Men's and Women's team competition. This is the first time the USA has won the overall medal counts in the 40-year history of the WCJJO.

Leonard Settles the Alliance Team Co-Captain and veteran of 4 World Championships led the USA to victory. Settles was undefeated in the weekend of events, competing in the Masters Division, BJJ Grappling, Individual Sport Jujitsu and Men's Team competition winning 3 Individual gold and a team gold medal as well as registering a record, 11 second fast submission in the Individual men's competition.

Michael Antonides, the USA Delegate and Executive board member of the WCJJO stated "The USA Team has been training for the past 2 years and team members were selected from a pool of competitors from 4 different Jujitsu Asso-



Ohio had a large number of competitors on the team including USJJF National Coach Mike Antonides from Ashland, Competitors Tirzah Gunther, Lucas Mast and Matt Butterbaugh from the Millersburg area in Holmes County, the Alliance Head Coach and competitor Leonard Settles, and competitors Joseph Stillisano, Sarah Thompson and Anna Seymour from the Cleveland Area and AJL Coaches Shawn, Craig and Isaac Chitwood and competitors Craig Chitwood, Mark Whitman, Katie Seher, Chris Tedjeske, Johnny Jardon, Aaron Behr and Vince Cooper from the Mansfield/Columbus area. Other Competitors from the USA were from New York, North Carolina, Florida and California.

ciates participating on 2 teams." USA Sports Jujitsu Alliance and Kwon USA were able to provide some of the funding for uniforms and travel.

The USA Team competition members were made up from The American Jujitsu League, Jujitsu America, United States Ju-Jitsu Federation and The USA Sports Jujitsu Alliance. The USA teams each entered as associations within the WCJJO competing against each other during the individual competition while the other organizations

fed players to the entering organizations. However, all were combined during the Team Competition. Antonides said "It was definitely a benefit to have the combined support from the two associations as it helped the USA dominate against the very large Australian and strong English team.

The next World Championship will be held in the USA in 2019.

## Lessons from Hanshi


"The Kwan Mu forms were composed to present a unified practice method for various styles of karate constituting the background of the Kwanmukan. These series of forms were originated by Grandmaster George Anderson in the early seventies and were finalized in 1976. They were extrapolated from the base styles of, taekwondo, tai soo do, kwan bup, Japanese and Korean karate, and kung fu. The manner is unique in that the generally accepted internationally recognized forms of karate were re-synthesized into a series of understandable action, now called the Kwan Mu forms.

### **Kwan Mu Exercise Patterns**

Besides having a firm technical base, these forms also represent valuable philosophical foundation. The collateral philosophies are ingeniously imbedded in the performance of the patterns and the practice of thereof will prove mentally beneficial..."

"The Kwan Mu patterns, in their totality, are only ones that any practitioners of the combat styles should have to practice. Beyond Kwan Mu, in our opinion, the paucity of technical pertinence in ordinary kata is readily apparent."
