To be qualified to test for Kobudo Dan ranks, the below must be met.

The student reached a minimum level of proficiency for the appropriate Dan grade in the required number from the below list. Three weapons are required for Shodan, four for Nidan and Sandan, and five for Yondan. Rank being applied for: Shodan Nidan Sandan Yondan Weapons Chosen: Sai Bo Tonfa Nunchaku Kama (eku will be treated as bo) Has ascertained at least a Shodan in Karate or Jujitsu. Applicant has been actively pursuing Kobudo for a minimum of six months prior to the date of application/test or Shihan's approval (signed) Date.
